### Administration

Stu Bresler and David Anders welcomed stakeholders and provided the Anti-trust, Code of Conduct, and Meeting Participation announcements. Phil D'Antonio announced a new mandatory reserve market training program for all Member operators which must be completed by September 30, 2023. The training will be deployed to the PJM Learning Management System on July 31, 2023. He also noted that PJM would be posting on July 26, 2023 guidance related to implementation of Performance Assessment Interval (PAI) trigger changes in anticipation of FERC approval on July 30, 2023 of PJM's related May 30, 2023 FERC filing while stressing that existing PAI rules remain in effect until FERC rules on our May 30, 2023 filing.

#### **Endorsements**

### 1. NERC TPL – 001 – 5.1 Manual 14B Revisions

Stanley Sliwa reviewed proposed revisions to Manual 14B: PJM Region Transmission Planning Process to align with the NERC TPL – 001 - 5.1 standard. Following discussion, the proposed revisions were **endorsed** by acclamation with no objections or abstentions.

## First Readings

## 2. Enhancements to Deactivation Rules Issue Charge

Paul McGlynn reviewed a Problem Statement and proposed Issue Charge offered by PJM and the Independent Market Monitor addressing enhancements to deactivation rules given the anticipated volume of generation resource retirements expected in the coming years and misunderstandings about how the current rules operate. PJM will consider feedback received and the committee will be asked to approve an updated proposed Issue Charge at it a future meeting.

### 3. Reserve Certainty Issue Charge

Donnie Bielak reviewed a Problem Statement and proposed Issue Charge addressing reserve certainty, defined as having the appropriate suite of ancillary service products procured at the necessary level coupled with the confidence in resources with an assignment to provide reserves to perform when called upon. He discussed three groups of concerns: the need for excellence in resource performance based on the experience during Winter Storm Elliott; the need to ensure resource adequacy based on findings from the recent Energy Transition in PJM: Resource Retirements, Replacements, and Risks report; and the need to maintain and attract essential Reliability Services as recommended in the Energy Transition in PJM: Frameworks for Analysis paper. PJM will consider feedback received and the committee will be asked to approve an updated proposed Issue Charge at it a future meeting.

### 4. Manuals (10:45-10:55)

A. Donnie Bielak reviewed proposed revisions to Manual 13: Emergency Operations addressing upcoming NERC EOP-011 Requirements. The committee will be asked to endorse the proposed Manual revisions at its next meeting.

## **Informational Reports**

### 5. Peak Market Activity)

Tom Zadlo and Yong Hu provided an informational update regarding the peak market activity (PMA) issue at the Risk Management Committee (RMC). He noted that the RMC is expected to vote on a single PMA proposal at the committee's August meeting. To facilitate implementation of the proposed solution in time for upcoming winter, the MRC may be asked to vote on the proposal at first read at its August meeting, or the MRC and the Members Committee may be asked to vote on the proposal at their September meetings.
