1. <u>Administration</u>

Ms. Lisa Morelli called the meeting to order and welcomed stakeholders. Ms. Cheryl Mae Velasco reviewed the draft meeting minutes from the 1/15 ERPIV meeting. The draft minutes were approved. Ms. Velasco reviewed the open action items and made mention that all items were to be addressed at the meeting. Ms. Morelli called attention to the Anti-trust and Code of Conduct statements.

2. <u>Review Workplan</u>

Ms. Morelli reviewed the draft workplan with the changes requested from the first meeting. No additional requests for changes were made.

3. Education

- a. Mr. Chris Pacella, at the request of stakeholders from the first meeting, presented interchange volatility as seen on January 7, 2014.
- b. Mr. Adam Keech reviewed the recently filed DR changes, discussing how these changes will impact future operations decisions. Emphasis was made on pre-emergency versus emergency DR and when those products would be called.

4. Interest Identification

PJM had pre-populated the Interest Identification portion of the matrix with a few interests for both portions of the Issue Charge. Mr. Chris Pacella presented PJM's interests regarding interchange volatility and Ms. Rebecca Carroll



presented PJM's interests regarding incorporating more operator actions in the energy and reserve pricing. Ms. Lisa Morelli led the stakeholders in brainstorming and identifying additional interests.

5. <u>Design Component & Solution Option Development</u>

- a. PJM pre-populated the matrix with design components and solution options for both the short term and long term solutions for both pieces of the Issue Charge. The design component and solution option development exercise was completed for the interchange volatility portion first. It was stated that while long term solutions would be documented and kept in the matrix, discussions on these solutions will be limited and the focus will be mainly on the short term solutions that may be implemented before June 2014.
- b. Mr. Chris Pacella presented the design components for the interchange volatility. Stakeholders were asked to brainstorm additional design components and ideas were documented. Long term components were kept in a separate tab to keep track of ideas. Once components were discussed, Mr. Pacella went on to present PJM's solution options, for both the short and long terms. Stakeholders were again asked to brainstorm solution options. A request to reword a solution option to incorporate DR decisions when limiting ramp was made and taken down as an action item for the next meeting. Stakeholders were encouraged to send any additional components and options prior to the following meeting.
- c. Ms. Rebecca Carroll presented the design components drafted by PJM for incorporating more operator actions in the energy and reserve pricing. Ms. Carroll also presented the solution options drafted by PJM for both the short and long term solutions. Stakeholders were also encouraged to send any additional components and options prior to the following meeting.
