1. Administration

Ms. Lisa Morelli called the meeting to order and welcomed stakeholders. Ms. Morelli reviewed the agenda and called attention to the Anti-trust and Code of Conduct statements. Ms. Cheryl Mae Velasco performed roll call and reviewed the draft meeting minutes from the 8/7 ERPIV meeting. The minutes were approved.

2. Review Workplan

Ms. Morelli reviewed the draft workplan. A request for clarification on when the MC vote would be taken was made. No other requests for changes were made.

3. <u>Interchange Volatility Solution Components and Options Development</u>

Ms. Rebecca Carroll reviewed PJM's proposal for interchange volatility. The conversation began with an overview of why interchange volatility is a concern and its impact on uplift. PJM decided not to pursue a product that would economically clear transactions, but rather discussed the use of an interchange cap. Ms. Carroll described how the interchange cap would be calculated and when the cap would be in effect. Additional changes to the already existing RT with Price Transactions product were also discussed.

4. Energy/Reserve Pricing Solution Components and Options Development

Mr. Adam Keech reviewed changes to the DASR market from the previous PJM proposal. He also discussed a new proposal that would be an extension of the short term solution. The new proposal would involve increasing the 10 minute reserve requirement by a value that more accurately reflects the amount of additionally scheduled units. This proposal was developed in response to the comments regarding the complexity of the new 30 minute reserve market, which was PJM's previous long term solution.
