Administration

Nicholas DiSciullo reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and the WebEx Participant Identification Requirements.

The Committee approved the draft minutes from the November 3, 2021 Market Implementation Committee meeting with **0 objections and 0 abstentions**.

Nicholas DiSciullo reviewed the 2022 MIC Work Plan.

Nicholas DiSciullo provided an update on the Start-Up Cost Offer Development issue. Alternative solutions than those covered during the November MIC meeting will be reviewed at the December 2, 2021 Cost Development Subcommittee meeting and brought back to a future MIC meeting.

Endorsements/Approvals

2. Fuel Cost Policy Standards and Schedule 2 Penalties

Melissa Pilong reviewed the PJM/IMM proposal, elaborating upon and addressing clarifications to Fuel Cost Policy standards and Schedule 2 Penalty language developed through the Cost Development Subcommittee.

The committee endorsed the PJM/IMM proposal with 221 (95%) in favor, 11 (5%) opposed, and 14 abstentions.

A second vote showed stakeholders preferred the PJM/IMM proposal over status quo with 192 (95%) in favor, 11 (5%) opposed, and 5 abstentions. Issue Tracking: Fuel Cost Policy

3. Manual 6 Revisions

Emmy Messina reviewed conforming changes to Manual 6: Financial Transmission Rights resulting from the endorsement of the AFMTF PJM/Joint Stakeholder package at the October MRC. **The committee endorsed the Manual 6 revisions by acclamation with 0 objections and 0 abstentions.**

4. Regulation for Virtual Combined Cycles

Michael Olaleye reviewed Package A addressing Regulation for Virtual Combined Cycles. The committee endorsed Package A by acclamation with 0 objections and 0 abstentions. A second acclamation vote showed stakeholders support the proposal over status quo with 0 objections and 0 abstentions.

5. Pseudo Modeled Combined Cycle Minimum Run Time Guidance

Tom Hauske provided education and a first read of a Problem Statement and Issue Charge addressing Pseudo Modeled Combined Cycle Minimum Run Time Guidance. The committee will be asked to approve the issue charge as part of the "CBIR Lite" process outlined in Section 8.6.2 of Manual 34 at its next meeting. If the issue charge is approved, the committee will begin interest identification and developing design components and solution options as part of the CBIR process at its next meeting.

6. De-Energized Bus Replacement

Vijay Shah provided a first read of conforming revisions to Manual 11: Energy and Ancillary Services Market Operations as part of 5 Minute Dispatch and Pricing. The changes address enhancements to the Dead Bus Replacement logic for assigning prices to de-energized pricing nodes. The committee will be asked to endorse the Manual revisions at its next meeting.

13. Capacity Offer Opportunities for Generation with Co-Located Load

Jason Barker, Exelon, provided a first read of a new Problem Statement and Issue Charge addressing the treatment of generation with co-located load. The committee will be asked to approve the issue charge at its next meeting.

Lisa Morelli facilitated a discussion to review and identify additional interests, design components and solution options on the Market Suspension matrix as part of the Consensus Based Issue Resolution process, and updates were provided during the meeting. A Post-Meeting version of the matrix has been posted to the meeting materials. The committee will continue the CBIR process by beginning to develop straw man proposals at its next meeting.
