Administration (9:00-9:15)

1. Dave Souder, PJM, called the meeting to order and Molly Mooney, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines.
2. Molly Mooney reviewed the May 12, 2020 Planning Committee Agenda. No changes to the agenda were requested.
3. Ms. Molly Mooney reviewed the draft minutes posted for the April 14th, 2020 meeting and the Planning Committee approved the minutes.

Dave Souder, PJM, announced on May 22nd there will be a special MRC session in the afternoon to conduct education related to HVDC Converters

Dave Souder, PJM, discussed the May 1 Executive Order on Securing the United States Bulk-Power System and the subsequently DOE outline “Four Pillars” of Actions on the President’s Executive Order. PJM will provide future updates as part of a PC agenda item.

Endorsements (9:15-11:15)

4. Storage as Transmission Asset
Jeff Goldberg, PJM, presented a second read of a problem statement/issue charge regarding storage as a transmission asset. **The committee endorsed the Storage as Transmission Asset issue charge with an acclamation vote of 1 objection and 0 abstentions.**
5. Market Efficiency Process Enhancement Task Force Update
Jack Thomas, PJM, reviewed the work completed at the Market Efficiency Process Enhancement Task Force. The Committee voted on three packages in the category: Regional Targeted Market Efficiency Project process (category A), three packages in the category: Benefit Calculation (category B), and two packages in the category: Window for Capacity Drivers (category C).
The committee voted on all eight packages with the following results:
 - Category A1 (PJM): 87 Yes (55%), 72 No (45%), 15 Abstain [PASS]
 - Category A2 (IMM): 19 Yes (12%), 143 No (88%), 12 Abstain [FAIL]
 - Category A4 (AEP): 89 Yes (56%), 71 No (44%), 14 Abstain [PASS]**The committee voted if A4 was preferable to the status quo. This vote passed with 97 Yes (58%), 71 No (42%), and 12 Abstain.**
 - Category B1 (PJM): 82 Yes (52%), 75 No (48%), 17 Abstain [PASS]
 - Category B2 (IMM): 26 Yes (16%), 135 No (84%), 13 Abstain [FAIL]
 - Category B4 (First Energy): 84 Yes (54%), 73 No (46%), 17 Abstain [PASS]**The committee voted if B4 was preferable to the status quo. This vote passed with 93 Yes (56%), 73 No (44%), 14 Abstain.**

- **Category C1 (PJM): 82 Yes (52%), 75 No (48%), 17 Abstain [PASS]**
- **Category C2 (IMM): 40 Yes (25%), 119 No (75%), 15 Abstain [FAIL]**

The committee voted if C1 was preferable to the status quo. This vote passed with 102 Yes (63%), 61 No (37%), 5 Abstain.

6. Critical Infrastructure Stakeholder Oversight

A. Robert Taylor, Exelon, presented a second read of a redline version of the Critical Infrastructure Stakeholder Oversight Issue Charge.

B. Erik Heinle, Office of the People's Council for the District of Colombia, presented an alternate to the redline version of the Critical Stakeholder Oversight Issue Charge.

The committee voted first on the Critical Infrastructure Stakeholder Oversight redlined issue charge from Exelon. The committee then voted on the alternate Critical Infrastructure Oversight redlined issue charge from the DC-OPC. The committee approved the redlined issue charge from Exelon with a vote of 95 Yes (61%), 62 No (39%), 25 Abstain. The committee did not approve the alternate redlined issue charge from DC-OPC with a vote of 51 Yes (39%), 80 No (61%), 24 Abstain.

First Reads (11:15- 12:15)

7. PMU Placement in RTEP Planning Process

Shaun Murphy, PJM, reviewed the Problem Statement, Issue Charge and proposed solution to address the need for PMU Placement in the RTEP planning process. PJM will schedule a PMU training session in advance of the June PC. The committee will be asked to approve the issue charge and endorse the proposed manual language as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at the June PC meeting.

8. 2020 RRS Assumptions

Jason Quevada, PJM, presented the 2020 RRS assumptions as developed in the Resource Adequacy Analysis Subcommittee. The committee will be requested to endorse the study assumptions at the June PC meeting.

9. Manual 14A, E and G Changes

Ms. Onyinye Caven, PJM, will present changes to Manuals 14A, 14E and 14G identified as part of the periodic review. The committee will be requested to endorse the Manual changes at the June PC meeting.

Model Build Activity Update

- The 2020 series RTEP Trial 3 powerflow cases and associated files are being reviewed by PJM staff and the Transmission Owners. The preliminary 5 year short circuit results have been provided to PJM's Transmission Planning Department; they will reach out to Transmission Owners with any questions. PJM's System Planning Modeling and Support Department will reach out about any potential baselines for the 2 year case.
- The 2019 series MMWG 2020 winter study case is being updated. There will be two Trials where Transmission Owners are able to provide updates. The final updates will be provided to PowerTech by PJM on May 22, 2020.
- For the 2020 series MMWG powerflow cases, Transmission Owners are able to submit updates to project files via Model on Demand, provide load and device profiles for all 12 cases and Tie Line updates to PJM by May 22, 2020.

MOD-032 Update

- Posted with materials for the May PC is a document describing 2020 MOD-032 updates. The Gen Model window will open May 1 and remain open through June 15. Generator Owners have the option of using data

PJM Interconnection Queue Status Update

PJM has posted slides showing an update on the status of the PJM Interconnection Queues.

Capacity Capability Senior Task Force Update

The Capacity Capability Senior Task Force charter was approved at the March 26 MRC in order to consider provisions to implement Effective Load Carrying Capability to calculate the capacity market capability of all Intermittent Resources (such as wind and solar) and limited duration resources (such as Energy Storage Resources). The group aims to complete a proposal in August for filing with FERC before October 30, consistent with a deadline FERC set in [an April 10 order](#). PJM proposed design components at the second meeting on April 27, and the group will consider proposed solution options at the May 20 meeting.
