Administration (1:00-1:15)

- Mr. Anders opened the meeting and reviewed the agenda.
- Mr. Chmielewski reviewed the meeting guidelines, performed roll call and reviewed the March 31st draft minutes. Minutes were approved and posted as final.

Voting Results Presentation (1:15-1:30)

 Mr. Brian Chmielewski, PJM Interconnection, LLC, presented the results of the binding vote. No solution package received a majority vote. The results of the non-binding question on Status Quo vs. Making a Change favored Making a Change, 60%, 40% for Status Quo.

Discussion On Historical Resources (1:30 – 2:13)

Mr. Brian Chmielewski and Mr. Tim Horger, PJM Interconnection, LLC, lead the stakeholders in a
discussion on possible future changes to the treatment of historical resources in the Annual ARR
Allocation. The final slide of the presentation, which contains the recommendation of PJM
Interconnection, LLC, was amended and reposted following member input during the discussions.

Open Discussion (2:13-2:50)

- Mr. Anders led the stakeholders in an open discussion on the future of the FTRSTF, noting the options
 of the group. After mixed opinions were recognized, the task force agreed to have one final conference
 call following any input from the PJM Board of Managers at the Liaison Committee Meeting next week.
- The final meeting will allow for any additional solution packages proposed by the group to be discussed, followed by a final binding vote.
- Please Note: there will not be re-voting on any existing package. The final vote will only be for new solution packages proposed by the membership or PJM Interconnection, LLC.
