RE: Additional LS Power Affiliates

Dear Mr. Liu:

On July 1, 2021, LS Power Associates, L.P. and its affiliates ("LS Power Group", also known as "LS Power") properly confirmed that its pre-qualification information submitted on July 16, 2018 remains valid and we remain qualified to be designated as a Designated Entity under the PJM Operating Agreement. At that time, we also provided CONFIDENTIAL audited financial statements of LS Power Associates, L.P. for 2020 and 2019, which include the most recent fiscal quarter available, as well as the most recent three fiscal years (2018, 2019, and 2020). LS Power Grid Mid-Atlantic, LLC was formed in January 2021 as an additional wholly-owned LS Power affiliate and subsidiary to pursue independent transmission within the PJM area, in addition to the other affiliates of LS Power Group such as Central Transmission and Silver Run Electric. These LS Power transmission entities look forward to ongoing and future participation in the PJM competitive windows, including, but not limited to, the upcoming New Jersey Offshore Wind Solicitation.

We would also alert you that there are three additional LS Power Group affiliates on the generating side of LS Power that will be separately providing additional information to PJM, including the below information:

- 1. Technical and engineering qualifications of the entity or its affiliate, partner or parent company;
- Demonstrated experience of the entity or its affiliate, partner or parent company to develop, construct, maintain and operate transmission facilities, including a list or other evidence of transmission facilities previously developed regarding construction, maintenance or operation of transmission facilities both inside and outside the PJM region;
- 3. Previous record of the entity or its affiliate, partner or parent company to adhere to construction, maintenance and operating standards;
- 4. Capability of the entity or its affiliate, partner or parent company to adhere to standardized construction, maintenance and operating practices;

- 5. Commitment by the entity to execute the Consolidated Transmission Owners Agreement, if the entity becomes a Designated Entity;
- 6. Evidence demonstrating the ability of the entity or its affiliate, partner or parent company to address and timely remedy failure of facilities; and,
- 7. Description of the experience of the entity or its affiliate, partner or parent company in acquiring rights of way.

These three affiliates of LS Power Group are 1) Rise Light & Power, LLC, 2) Light & Power Development, LLC, and 3) Helix Ironwood, LLC. Helix Ironwood, LLC is a current PJM Member. Like other LS Power affiliates, they should be considered pre-qualified to be a Designated Entity, and also should have access to the Competitive Planner Tool. Because these LS Power affiliates are on the generating side of LS Power, we ask for their access to the Competitive Planner Tool to be separate from the other LS Power affiliates, so we can be fully compliant with our company protocols related to separation between our generation and transmission business.
