1. **Administration** (1:00 – 1:10)

Mr. Bowring, Monitoring Analytics presented further information and clarification on the MMU and PJM package proposal. Ms. Ford opened the floor for further package refinement from members. Packages E and H were added to the FMU Adders matrix. Concluding this discussion, members were shown a draft of the upcoming FMU Adders Package Poll by Ms. Portray. The FMU Adders Poll was provided to members Thursday April 3 and will remain open until noon (12pm) Monday April 7, 2014.

Stakeholders continued developing design criteria and began discussions around solution packages for RPM Supply Curve Transparency. Mr. Zadlo, PJM Interconnection provided status quo data for RPM Supply Curve Transparency to provide greater clarity to members. Mr. James Wilson, Wilson Energy Economics provided a supply curve smoothing moving average approach with assistance from Mr. Jason Barker of Exelon. No new packages were presented.
