1. Administration

Ms. Lisa Morelli called the meeting to order and welcomed stakeholders. Ms. Morelli reviewed the agenda and called attention to the Anti-trust and Code of Conduct statements. Ms. Cheryl Mae Velasco performed roll call and reviewed the draft meeting minutes from the 6/25 ERPIV meeting. The minutes were approved.

2. Review Workplan

Ms. Morelli reviewed the draft workplan. No other requests for changes were made.

3. Issue Charge Clarification

At the previous meeting, there was a request made for clarification surrounding the joint discussion of the two pieces of the issue charge. Since there was no time in the MRC agenda to discuss whether the interchange volatility solution should be worked through along with the energy/reserve pricing solution, Ms. Morelli looked to the stakeholders for feedback regarding their interests. With no significant push for either approach, it was decided that the focus of the discussions will be the energy/reserve pricing solution, with the intent to discuss the interchange volatility solution once the conversation has come to a logical stopping point. Both pieces of the issue charge will be filed together.

4. Education

Mr. Angelo Marcino provided the group with an overview of Shortage Pricing and how the proposed 30 minute secondary market would fit in the current construct.

5. Review of PJM Energy/Reserve Pricing Solution Components and Options

Mr. Adam Keech presented PJM's proposal for a real time 30 minute reserve market. He highlighted the changes made to the proposal since the last meeting. A request was made to provide examples for how the requirement would be set. An additional request was made to provide empirical examples of the new market construct. PJM has filled out the long term matrix with the majority of the components and options filled out for the 30 minute reserve market proposal, however there are still a few components that need to be discussed internally.

7. Review of Energy/Reserve Pricing Alternate Solution Components and Options

Mr. Dave Scarpignato, Direct Energy, reviewed an alternate proposal that was brought forth by a group of stakeholders that met separately called the New Reserve Product Coalition. The group proposed a solution that involved an Extraordinary Reserve product. There was discussion among the members surrounding having an operating reserve demand curve for the Extraordinary Reserve product and whether or not it was necessary to



include. It was requested that the matrix be filled out with the elements of the proposed solution so that members may see where similarities and differences lie between the two proposals.

The discussion surrounding the Energy/Reserve Pricing solutions extended through the length of the meeting. The interchange volatility education and proposed solutions will be discussed at the next meeting.
