Administration

1. Ms. Bhavana Keshavamurthy and Ms. Lisa Morelli provided announcements; reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation, the WebEx Participant Identification Requirement, and [Issue Tracking](#).

The Committee approved the draft minutes from the September 11, 2019 Market Implementation Committee meeting with **0 objections and 0 abstentions**.

- A. Ms. Rebecca Carroll, PJM, provided an update on the Performance Assessment Interval (PAI) event that occurred on October 2, 2019. PJM will review a PAI Operational Report at the November Operating Committee meeting. PJM will also post a FAQ document summarizing questions received from stakeholders by October 21, 2019.

Endorsements/Approvals

2. ARR/FTR Market Review

Note: Discussion and voting on this item was postponed to later in the meeting due to speaker availability.

- A. Mr. Howard Haas, Monitoring Analytics, presented the problem statement and issue charge related to the review of the ARR/FTR Market construct. Ms. Jennifer Tribulski, PJM, proposed a friendly amendment to include reference to the GreenHat report recommendation F3 in the issue source. Mr. Haas accepted the friendly amendment and the issue charge was modified to reflect the friendly amendment.
- B. Mr. Mike Borgatti, Gabel Associates, presented an alternate issue charge related to the review of the ARR/FTR Market construct.
- C. Dr. Roy Shanker, representing the Financial Marketers Coalition, presented an alternate issue charge related to the review of the ARR/FTR Market construct.

There was extensive discussion amongst the stakeholders to determine if the alternate issue charge language as proposed by Mr. Borgatti would exclude discussion on some issues related to the design of the ARR/FTR Market construct. Mr. Borgatti amended the Issue Content and Key Work Activities sections of the issue charge to clarify that all issues germane to the comprehensive review of the ARR/FTR market design are included in the scope of the issue charge. Ms. Ruta Skucas, representing the Financial Marketers Coalition, withdrew their issue charge and voiced support for Mr. Borgatti's issue charge. The issue charge, now termed as the Stakeholder Coalition issue charge and the IMM issue charge were voted in succession by the committee.

The committee did not endorse the IMM issue charge with 86(36%) in favor, 154(64%) opposed and 34 abstentions.

The committee endorsed the Stakeholder Coalition issue charge with 213(100%) in favor, 1(0%) opposed and 33 abstentions.

3. **Interregional Incremental Auction Revenue Rights**

Mr. Brian Chmielewski, PJM, requested a vote to close this issue charge. Absent stakeholder feedback PJM recommended Status Quo.

The committee will be asked to endorse the manual revisions at the November MIC.

5. **Manual 15 revisions related to VOM Compliance Filing**

Mr. Thomas Hauske reviewed conforming revisions to Manual 15: Cost Development Guidelines consistent with the May 10, 2019 VOM Compliance Filing that was recently accepted by FERC.

Mr. Hauske also reviewed the necessary actions Market Sellers must take in order to comply with the upcoming Fuel Cost Policy Annual Review deadline.

The committee will be asked to endorse the manual revisions at the November MIC.

6. **Stability Limits in Markets and Operations**

Mr. Liem Hoang, PJM, and Mr. Michael Zhang, PJM, provided education on Modeling Units with Stability Limitations. Ms. Morelli, PJM, noted that the committee would begin working through the interests and design component identification for this issue at the November MIC.
