Administration

Ms. Daugherty and Mr. Anders welcomed the participants, and provided the announcements and antitrust and code of conduct announcements.

Mr. Tom O'Brien discussed recent phishing attempts and offered recommended precautions that stakeholders should take to protect their systems.

Endorsements/Approvals

1. <u>Draft Minutes</u>

Minutes of the March 23, 2017 meeting of the Markets and Reliability Committee (MRC) were **approved** by acclamation with no objections and one abstention.

2. PJM Manuals

A. Mr. Michael Herman presented revisions to Manual 14B: PJM Region Transmission Planning Process. Updates include: correcting wording in the Baseline Thermal Analysis section to match analytical procedures and changing all occurrences of "Special Protection System" to "Remedial Action Scheme" per a change to the NERC glossary of terms. Following discussion, the committee **endorsed** the proposed revisions by acclamation with no objections or abstentions.

3. Energy Market Uplift Sr. Task Force (EMUSTF)

Mr. David Anders presented the proposed Phase 3 solution endorsed by the EMUSTF. Ms. Ruta Skucas moved and Mr. Joe Wadsworth seconded that voting on the proposed Phase 3 solution be deferred until FERC has acted on the Phase 2 solution. The motion to defer **failed** in a sector-weighted vote with 1.04 in favor. Ms. Noha Sidhom moved and Mr. Joe Wadsworth seconded an alternate motion to approve the full proposal but separate the filings at FERC into two parts: one filing to address removal of "dead busses", and a second to include the remainder of the proposal. Following discussion, the committee **endorsed** the Phase 3 proposed OA, Tariff and manual revisions in a sector-weighted vote with 4.07 in favor.

4. Regulation Market Issues Sr. Task Force (RMISTF)

Mr. Eric Hsia presented the proposed regulation market enhancements endorsed by the RMISTF. Mr. John Horstmann moved and Mike Borgatti seconded that the vote on the proposal be postponed until the June 2017 MRC meeting. The motion to defer **passed** in a sector-weighted vote with 3.76 in favor. The committee will be asked to endorse the proposal at its June, 22, 2017 meeting.

5. Capacity Construct / Public Policy Sr. Task Force (CCPPSTF)

Mr. David Anders presented the draft charter for the CCPPSTF. Following discussion, the committee **approved** the proposed charter by acclamation with one objection and two abstentions.

6. Seasonal Capacity

Ms. Terri Esterly will present proposed revisions Manual 18: PJM Capacity Market which conform to the recent Enhanced Aggregation FERC order related to seasonal capacity participation in RPM as Capacity Performance resources. Dr. Bowring proposed friendly amendments as follows (amendments in red):

Section 4.9 Aggregate Resources

 The location of Any replacement capacity specified for an Aggregate Resource must be located in the LDA in which the Aggregate Resource was modeled in accordance with the Replacement Capacity transaction business rules in Section 8.9 of this manual.

Section 5.7.3 Resource Make-whole Payments in Base Residual Auctions (same change would be needed in Section 5.8.3 Resource Make-whole Payments in Incremental Auctions)

Effective with the 2020/2021 Delivery Year, a resource provider that offered and cleared a Seasonal Capacity Performance sell offer for which the sell offer price exceeded the clearing price determined for such resource as a result of the seasonal matching process in the post-processing of the auction results as described in Section 5.7.2 will receive a Resource Make-whole Payment. The Resource Make-whole Payment is equal to the difference between the sell offer price and clearing price for such resource determined as a result of the seasonal matching process, multiplied by the cleared MW quantity.

There was no objection to these proposed amendments and therefore they were incorporated in to the proposed revisions. Following discussion, the committee **endorsed** the proposed revisions by acclamation with no objections and three abstentions.

Mr. Scott Baker provided a final report of the Seasonal Capacity Resources Sr. Task Force (SCRSTF). Stakeholders discussed the potential to sunset the SCRSTF, and may be asked to vote on sunsetting at a future meeting.

First Readings

7. Annual Revenue Requirements for new Black Start Units – Phase 1

Mr. Tom Hauske presented the solution package for the Annual Revenue Requirements for new Black Start units. The committee will be asked to endorse the proposed revisions at its next meeting.





8. Pseudo-tied Generators and Dynamic Schedules Meter Correction Proposal

Mr. Ray Fernandez presented the Pseudo-tied Generators and Dynamic Schedules Meter Correction proposal and governing document revisions that was endorsed by the Markets Settlements Subcommittee. The committee will be asked to endorse the proposed revisions at its next meeting.

9. Primary Frequency Response Problem Statement and Issue Charge

Mr. David Schweizer reviewed a proposed problem statement and issue charge related to generator Primary Frequency Response requirements. The committee will be asked to approve the proposed problem statement and issue charge at its next meeting.

10. Long Term FTRs Problem Statement and Issue Charge

Mr. Asanga Perera discussed a proposed problem statement and issue charge to address enhancements to long-term FTR modeling related to potential congestion impacts for future transmission system changes. The committee will be asked to approve the proposed problem statement and issue charge at its next meeting.

11. PJM Manuals

- A. Ms. Nicole Scott reviewed proposed changes to Manual 03: Transmission Operations related to the periodic review of the manual. The committee will be asked to endorse the proposed revisions at its next meeting.
- B. Mr. Brian Chmielewski discussed conforming Manual 06: Financial Transmission Rights revisions related to the FERC Order impacting the annual ARR/FTR process. The committee will be asked to endorse the proposed revisions at its next meeting.
- C. Mr. David Schweizer and Mr. Joe Mulhern presented proposed revisions to the tariff and Manual 14D: Generator Operational Requirements related to requirements for solar parks. The committee will be asked to endorse the proposed revisions at its next meeting.
- D. This item was deferred to a future meeting.
- E. Mr. Glen Boyle reviewed proposed changes to Manual 36: System Restoration related to the periodic review of the manual. The committee will be asked to endorse the proposed revisions at its next meeting.

Mr. Lagy Mathew provided an update regarding Automatic Sectionalizing Schemes.

13. <u>Designated Entity Design Standards Task Force (DEDSTF)</u>

Mr. Herman presented the minimum design requirements document created by the DEDSTF. DEDSTF requirements must be followed for all proposals that will require the signing of a Designated Entity Agreement. Mr. Herman discussed plans for management of these processes in the future.





14. BGE Remedial Action Schemes (RAS)

Mr. Eric Yeh, BGE, discussed retirement of Concord RAS and the extension of Mt Washington RAS.
