## Administration

Stu Bresler and Dave Anders welcomed stakeholders and provided the Anti-trust, Code of Conduct, and Meeting Participation announcements.

Consent Agenda

Paul Sotkiewicz, Elwood Energy, LLC, moved and Jeff Whitehead, Eastern Generation, LLC, seconded deferring voting on item F until the sunset of the Resource Adequacy Sr. Task Force. The motion to defer **failed** in a sector-weighted vote with 3.329 in favor. Following discussion, Consent Agenda item F **failed** in a sector-weighted vote with 2.17 in favor:
