- Periodic Review – Revision 29
 - Annual review of Manual 6 per Manual 34
 - Conforming changes per ER17-1433-003
 - Updates and formatting throughout the manual
 - Effective Aug. 24, 2022

- ARR FTR Market Task Force (AFMTF)-based changes – Revisions 30 and 31
 - Two phases of conforming changes resulting from the AFMTF
 - Phase 1 – FTR changes – Effective Sep. 1, 2022
 - Phase 2 – ARR changes – Effective Feb. 1, 2023
 - Filing ER22-797-000 approved by FERC on Mar.11, 2022

- Conforming changes per ER17-1433-003
 - Update section 8.6 to reflect the new forfeiture rule, which removes the penny test and replace it with forfeitures based on constraint contributions
- Updates
 - Manual owner changed to Eric Hsia in approval section
 - Removal of text in section 8.1 for FTRs that cover multiple planning years as they are no longer available and existing FTRs of this type (YRALL) have expired
 - Revised general statement about ARR sources and sinks in section 2.1 and 3.1.1 to be applicable to all rounds of ARR Allocation
- Formatting throughout the manual

- AFMTF-based conforming changes per ER22-797-000 with effective date of Sep. 1, 2022
 - New Class Types
 - Added definitions of new class types and clarified remaining timeframe for existing OffPeak class type in section 6.1
 - Option Floor
 - Added new rule for clearing to section 6.1 that Options with a market-clearing price less than \$1 will not be awarded

- AFMTF-based conforming changes per ER22-797-000 with effective date of Feb. 1, 2023
 - Stage 1A Nomination MW Change from ZBL to 60% NSPL
 - Section 4.2, Section 4.7, Section 4.8
 - Self-scheduling by Class Type
 - Section 6.1
 - Replaced “path” with “source and sink” in section 2.2 for clarity
 - Expanded Sources/Sinks for ARRAs
 - Section 4.1, Section 4.3, Section 4.5
 - Reduction from 3 to 2 Rounds for Stage 2
 - Section 4.1, Section 4.4, Section 4.5
 - Changes to Sources/Sinks for IARRs
 - Section 4.9.3
