IMM proposal with 13 (11%) in favor, 107 (89%) opposed, and 1 abstention. A second vote showed stakeholders did not prefer the IMM proposal over status quo with 13 (11%) in favor, 107 (89%) opposed, and 1 abstention.

The PJM proposal will move on to the Market and Reliability Committee (MRC) as the main motion with 89% support and 89% preference over status quo.
