Roster Information

- Company representatives must be on a roster in order to vote
 - Each Member is allowed 1 primary and 3 alternate representatives per committee roster
 - Roster updates can be made via the <u>Roster Update Form</u> on PJM.com
- A roster representative may designate a one time proxy voter for a particular meeting if no roster representatives will be available to vote during that meeting
 - Proxy designations can be made via the <u>Single Meeting Voter</u> <u>Designation Form</u>



Voting Application Information

- The Voting App can be accessed at <u>https://voting.pjm.com/voting/pages/secure/</u>
 - Both Voting and Affiliate Members can vote at the RMC
 - Only one roster representative or designate voter can vote for a Member company during a vote
 - A user must have Voting Read/Write access in Account Manager to access the Voting Application
 - Voters can log in and vote or change previously submitted votes, as long as the vote remains open

- The Welcome page will list all groups currently using the Voting Application
 - Upon logging in, you will be made the active voter for any company for which you are on the roster
 - Verify that information is correct and hit Continue
 - If there is a company for which you will not be voting (or would prefer to vote for at a later time), hit Continue and navigate to the Registration Details page to unregister for that company
