### Administration (9:00 – 9:15)

1. Scott Baker, chair, opened the meeting and reviewed the agenda.
2. Nicole Militello, secretary, reviewed the meeting participation guidelines. The updated minutes from the last DIRS meeting were approved with 0 objections and 0 abstentions.
3. Thomas DeVita, PJM, provided a summary of FERC Order 2222-B.

### Order 2222 – EDC Coordination Workshop (9:15 – 11:30)

4. Distribution utilities provided additional feedback on the PJM straw proposal.
  - Steven Hughes, PPL Electric Utilities Corp., started the discussion covering the following topics: EDC Core Principals and Requirements, Operational Coordination Models, Telemetry models, EDC Override Authority and Cyber Security.
  - Ed Stein, Ohio Edison Company, continued the discussion covering Real Time Data Flows and settlement process implications.
  - Steven Hughes, PPL Electric Utilities Corp., completed the discussion by reviewing potential Use Cases.

### Order 2222 – Proposal feedback and Use Case discussion (11:30 – 12:00; 12:45 – 2:00)

5. Scott Baker provided an update on DERA use case development and use of the compliance matrix for tracking stakeholder alternatives.
  - Scott Baker discussed high level the various use cases PJM is working on and solicited feedback for additional use cases.
  - Scott Baker reviewed updates made to the Order 2222 Compliance Matrix as well as reviewed new and updated parking lot items.
6. Jeff Dennis and Prusha Hasan, Advanced Energy Economy, will provide feedback on the PJM straw proposal.
  - Jeff Dennis, Advanced Energy Economy, began the discussion by introducing Advanced Energy Economy (AEE), explaining the importance of DERs, the benefits of aggregated DER as well as general RTO Compliance Recommendations.

- Prusha Hasan, Advanced Energy Economy, continued the discussion by reviewing four (4) Order 2222 DER Use Cases and providing feedback from the recommendations discussed at the May DIRS.
- Jeff Dennis, Advanced Energy Economy, wrapped up the discussion by covering next steps.


## Solar-Battery Hybrid Resources (2:00 – 3:55)

- Information Only -- FERC Staff whitepaper on hybrid resources & Order directing reports from ISO/RTOs
  - Scott Baker shared that the FERC Staff whitepaper was available with the posted materials but would not be discussed during the meeting.
- Andrew Levitt, PJM, reviewed the PJM staff proposal (package A in the solutions matrix).
  - Andrew Levitt reviewed a presentation which covered all clarifications and updates to the PJM staff proposal since it was previously reviewed at the May DIRS.
  - Andrew Levitt reviewed the same changes within the matrix and made edits based on stakeholder feedback.
  - Jim Davis, Dominion, reviewed an additional solution option, package C in the solutions matrix.
- Stakeholders discussed the solution packages in the matrix and tested for support to make a recommendation to the Markets and Implementation Committee.
  - Stakeholders had no objections to taking both proposals to July MIC.
