Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the January 16, 2020 MSS meeting.

Members were asked to provide any updates to their NSPL scaling plans. No updates were provided.

Working Issues

1. RPM Billing Changes for 2020/2021 DY

Mr. Ed Rich, PJM, provided an update on the upcoming RPM billing changes for the 2020/2021 delivery year. A request was made to have the LSE PRD Credit Billing Line Items to be provided on a zonal level. PJM will discuss the issue internally, circle back with the requesting parties, and provide an update at the March MSS meeting.

2. Load Reconciliation Problem Statement/Issue Charge

During the January MSS meeting, concerns were raised regarding the proposed solution option of increasing settlement invoice timing to 3 months, which would cause FERC EQR reporting and RPS requirement issues. Ultimately, members decided that remaining with the status quo would be the preferred option on this problem statement/issue charge for a majority of design components and solution options. The InSchedule Data Submission Format design component and possible solution option to allow submittals for the final or the delta value will be discussed further at the March MSS meeting.
