Part 2 - Base Cases will be handled by PJM. No need to respond.

Part 3 - Maps and Diagrams - Please check the attached list (T.O. Drawing List.xls) of all the maps and diagrams that we have. If a newer or additional map is available, please forward it to me.

Part 4 - Reliability Criteria - I have included a copy of criteria from the PJM 2023 FERC Form 715 filing. It contains several files so I zipped it. If revised please include a redline version for use by PJM Planning.

Part 5 - Assessment Practices - I have included a copy of assessment practices from the PJM 2023 FERC Form 715 filing. It contains several files so I zipped it. If revised please include a redline version for use by PJM Planning.

Part 6 - Evaluations will be handled by PJM. No need to respond.

The PJM role is that of compiler and coordinator. If there are no changes from your submissions of previous years please inform me of that fact and I'll use the information from those previous filings.
