1. Administration

Ms. Burlew called the meeting to order and Mr. Baker called roll. Mr. Baker reviewed the minutes from 05.04.2012 (meeting #4), which were approved without changes.

2. Issue Work Plan

Mr. Schofield expressed concern over the timeline the group is following and commented that he did not feel an urgent need to establish a LTCA prior to the next BRA. Mr. Liebermann seconded that comment and asked to poll the group to see if there was support for slowing down the market development process. Ms. Burlew asked that we revisit the timeline at the end of the meeting.

Mr. Horstmann commented on whether or not there was still a need for the LTCA given the recent results of the BRA.

3. <u>Long-term Capacity Auction – Non-binding Survey</u>

Ms. Burlew led a discussion of the results of the non-binding survey. Results are posted in the 05.24.2012 meeting materials on the CSTF webpage.

Mr. Schofield commented on the possible confusion of respondents given conflicting results of design components #1 and #19. This may represent the need for more education on the design component options.

Mr. Horstmann commented that we don't have a feel for the credit requirements associated with design component #19. This comment led to a discussion on credit.



4. Overview of Credit Implications

Mr. Loomis led a discussion of credit implications of different market design solution options and walked through the credit scenarios of auction results previously used by Mr. Bastian in the education presentation for solution package #1. Mr. Loomis also directly addressed Mr. Horstmann's comment by walking through a generator default example and the credit implications thereof. Mr. Loomis' slides are posted on the CSTF website under the 05.24.2012 meeting materials

5. <u>Long-term Capacity Auction Matrix – Reduce Solution Packages</u>

Ms. Burlew reviewed the current status of the Matrix and led a discussion on design components ID #1, #2, #6, #10, and #16 – which are some of the more critical features the market design. Because the poll results indicate decent support for packages #1 and #3, the suggestion was made to create new packages that were slight modifications to packages #1 and #3, rather than create whole new packages from scratch. One suggestion was to label these packages "1a" and "3a". The beginnings of a package "1a" started to be filled out in the Matrix.

6. Task Force Timeline

Ms. Burlew led a discussion regarding the timeline to address concerns raised at the start of the meeting. The group decided not to meet on May 31st to allow for more discussion between stakeholders on the solution packages. In addition, the sentiment from the group is that the process is moving too quickly to develop a viable auction design and format with broad support. A discussion topic for the next meeting will be the FERC filing to be made on August 1st.
