Mr. Baker reiterated that elimination of the STRPT is out of scope for the CSTF. Mr. Bowring changed the solution option for that design component to the current wording

- Mr. Baker requested the voluntary removal of any packages. There were none offered.
- Mr. Baker announced that a non-binding poll would be sent out on Monday, January 13, to determine the level of support for remaining proposals.
