The document listing of what is thought of to be included or excluded in terms of End of Life Facilities within the PJM planning process has already been posted in the 10/25 meeting materials. Mr. Ringhausen agreed to draft an EOL definition and present to the TRPSTF at the next meeting. The proposed EOL definition will be posted onto the TRPSTF website.
