## **ERRATA**

**To: Parties to FERC Docket No. ER15-303**

**Re: American Transmission Systems, Incorporated  
PJM Open Access Transmission Tariff, Attachment H-21  
Projected Transmission Revenue Requirement for Rate Year 2019**

Pursuant to section II.D of the Formula Rate Implementation Protocols (“Protocols”) set forth in Attachment H-21B of the PJM Open Access Transmission Tariff (“PJM OATT”),<sup>1</sup> American Transmission Systems, Incorporated (“ATSI”) is submitting a Projected Transmission Revenue Requirement for Rate Year 2019 (“2019 PTRR”) to PJM for posting.

**ERRATA:** On October 16, 2018, ATSI posted an updated 2019 PTRR to replace the 2019 PTRR that had been posted one day earlier. ATSI hereby posts a new updated 2019 PTRR to correct an error in the October 16, 2018 version of the 2019 PTRR.

The error occurred in the true-up interest calculation on Appendix H to ATSI’s formula rate template. For Year 2017, the monthly Calculated Interest amounts were inadvertently subtracted from the monthly Under Recovery amounts, decreasing the Refund total for Year 2017. The understatement of the Year 2017 Refund carried through the calculations for Year 2018 and Year 2019, resulting in an understatement of the overall True-up with Interest total by \$1,233,669.

The correction of this error resulted in an increase to line 6b of Page 1 (True-up Adjustment With Interest) and Line 7 of Page 1 (Net Revenue Requirement) by \$1,233,669, thus increasing Line 16 of Page 1 (Annual Network Rate) by \$96.19; Lines 17 to 21 of Page 1 (Point-To-Point Rates) were also increased accordingly.

The 2019 PTRR was developed pursuant to the ATSI formula rate as set forth in Attachment H-21 of the PJM OATT. ATSI has asked PJM to post a copy of the 2019 PTRR to the formula rates section of its internet site, located at:
