Pursuant to the Formula Rate Implementation Protocols ("Protocols") of Public Service Electric and Gas Company ("PSE&G"), contained in Attachment H-10B of the PJM Interconnection, L.L.C. ("PJM") Open Access Transmission Tariff ("OATT" or "Tariff"), PSE&G hereby submits to the Federal Energy Regulatory Commission ("Commission") its Formula Rate Annual Update for 2025 ("Annual Update"). This 2025 Annual Update sets forth PSE&G's annual transmission revenue requirement, calculated in accordance with its Formula Rate for network transmission service under the PJM Tariff for the period commencing January 1, 2025 through December 31, 2025. The 2025 Annual Update also includes a True-up Adjustment for the 2023 Rate Year (January 1, 2023 through December 31, 2023).

In accordance with the Protocols, PSE&G submits this Annual Update filing for informational purposes only, and no action by the Commission is required.¹ As required by the Protocols, PSE&G is also providing a copy of this filing to PJM for posting on the PJM website.² Exhibit 1 of this filing includes a copy of PSE&G's
