On March 13, 2024, as amended on April 2, 2024, and May 14, 2024, PJM Interconnection, L.L.C. (PJM) submitted revisions to the Amended and Restated Operating Agreement of PJM Interconnection, L.L.C. (OA), Schedule 12, and the Reliability Assurance Agreement Among Load Serving Entities in the PJM Region (RAA), Schedule 17, to update the member lists to include new members, remove withdrawn members, reflect signatories to the RAA, and reflect member corporate name changes for the fourth quarter of 2023.¹ PJM requested that the proposed revisions to the OA and RAA be accepted effective December 31, 2023 and January 1, 2024. Pursuant to authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, the submittals are accepted for filing, effective December 31, 2023 and January 1, 2024,² as requested.³

The filings were publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission's regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed document(s); nor shall such action be deemed as recognition of any claimed
